EFFECTIVE IMMEDIATELY, SEPARATIONS INITIATED UNDER THE PROVISIONS OF AR 635-200 AND AR 135-178 FOR ENLISTED SOLDIERS DIAGNOSED WITH GENDER DYSPHORIA OR FOR SOLDIERS WHO ARE TRANSGENDER MUST BE FORWARDED THROUGH THE HEADQUARTERS, DEPARTMENT OF THE ARMY (HQDA), DEPUTY CHIEF OF STAFF, G-1 (DCS, G-1), TO THE ASSISTANT SECRETARY OF THE ARMY (MANPOWER AND RESERVE AFFAIRS) (ASA (M&RA)) FOR DECISION.
- B. EFFECTIVE IMMEDIATELY, SEPARATIONS INITIATED UNDER THE PROVISIONS OF AR 600-8-24 AND AR 135-175 FOR OFFICERS DIAGNOSED WITH GENDER DYSPHORIA OR FOR OFFICERS WHO ARE TRANSGENDER MUST BE FORWARDED THROUGH THE DCS, G-1 TO THE ASA (M&RA) FOR DECISION.
